This Procurement Notice is issued by the Government of Bermuda (the “Government”) to provide summary information in relation to a specific procurement, as detailed below.

### 1. Subject Matter of Procurement

RFX Title: **Tynes Bay Waste to Energy Facility - Continuous Environmental Monitoring System Refurbishment**

RFX Number: **2023-002-TB**

Purchase Type: **Construction**

The Government of Bermuda’s Tynes Bay Waste-to-Energy Facility would like to enter into an agreement with a supplier to refurbish the integrated Continuous Environmental Monitoring Systems that provide measurement, analysis, record recording, data transfer and reporting of the volumes of various types of gases and particulate matter in both existing stack flues.

The supplier will be required to remove the existing equipment, prepare the monitoring building and flue portals for the new equipment, install the equipment including all cables and connectors, test and commission the new systems. The supplier shall provide scheduled maintenance services and calibration of the equipment, biannually, for three years after the systems are commissioned.
