Listed below is the Executive Summary of the Scope of Works for the Horseshow Bay Transportation Hub Development.

- Request for Proposal to develop a new transportation hub for the Government of Bermuda
- Development location is limited to the west by Fairmont Southampton Hotel boundary, to the north; approximately 10 feet pass the existing rockcut, to the east near the overflow parking area turnaround and to the south to the existing washrooms.
- **Scope of Works**
 - New timber pedestrian boardwalk with view corridor and seating along southern portion of the property connecting into concrete sidewalk with ramp down to existing main beach access area
 - New integrated stormwater management swales and civil structural stormwater management systems
 - Reposition existing asphalt roadway to the northern part of the property with circular vehicular loop and associated rockcuts.
 - New bus, shuttle/mini-bus & taxi drop-off zones and car & bike parking with turfgrass surface. Accessible car parking area to be in concrete with flush/dropped precast concrete curbs.
 - Reposition existing salt water pump for existing bathroom facilities
 - New retaining wall & seating area near bus passenger drop-off area
 - Removal of invasive species of plants and trees, retaining & protecting existing species of plants and trees and planting new plants and trees
 - New parking facility lighting with Belco electrical poles and lighting fixtures.
